Graves are filled, numbers are given to the bodies of human beings and chaos ensues in emergency services, whether public or private (Lobo, A. et al., 2020). In recent times, nothing seems to make sense to us, nor the understanding of what comes to be compassion. COVID-19 still brought the worst of us and after 12 months and everything we experience, we see a pandemic driving others. The dysfunctional or absent empathy, the disrespect for oneself and for the other, the lack of limits, exposes with concern the real stage of our own civilizing process and places us in the greatest humanitarian lockdown ever seen. It is a shame for us Brazilians to write in history this emerging public health catastrophe where the people die "suffocated". This unprecedented public health calamity obviously exposes and "steals" the dignity of the country's most marginalized population: poor, black and indigenous (Lobo, A. et al., 2020), (The Lancet, 2019) and (Lasco, G. 2020). Although the reasons are several and considered in the political-economic context run by the Government of President Jair Messias Bolsonaro, it is imperative to focus this citizen as one of the main responsible for multiple and countless failures, but mainly for the disorganization and lack of empathy for his people. This way of governing COVID-19 stands out for its impressive lack of regard for public health, for scientists, for health professionals and, undoubtedly, for the human being. The public health guidelines (Lasco, G. 2020) issued at the state and municipal levels, as well as by global health leaders in the World Health Organization (WHO), among others (The Lancet, 2019), are popularized and scorned by the speech of sarcasm, hatred and circus grace. Bolsonaro is not, of course, alone in this misfortune. Added to it, parallel "leaders" who aim at a kind of horror game. Congratulations, president, for ignoring science (Idrovo, A. et al., 2020). Bolsonaro's "nefarious" stance, not only in relation to the pandemic, however on several topics that encompass public health and environmental policy in Brazil, was characterized as an antiscientific, amoral, unethical and inconsequential speech, where scientific information, even officials of their own government, are possibly neglected, "distorted" or obscure, when they contradict political and ideological points that displease him (Fundación Ciudadanía Inteligente, 2020).

FINAL CONSIDERATIONS

The decisions to hide data could not only affect surrounding countries, but also sabotage the performance of their own ministers and the governments of their countries' states, putting millions of vulnerable people at risk - a fact that unfortunately happened. Transparency in public health data is not only of great use for organizing the immediate response, establishing goals in the short, medium and long term. Such clarity is essential for international cooperation, a form of awareness and "defense" of the people, aiming at a stronger and more effective responsibility and participation power in our community. The lack of data transparency favors corruption and affects democratic mechanisms(Rahimi, F. et al., 2020) I believe this is enough for this editorial.
